## To Register:

We use the <u>UCLA LL.M. Interview Program Symplicity</u> system. Employers must first create or access a Symplicity account, then register for the 2022 Interview Program.

### **New Employers - Create Your Symplicity Account**

If this is your first time participating in our program, click <a href="here">here</a> and select "Sign Up" to quickly and easily create your account. You will be asked to fill out some basic contact information so that we can follow up with you. Once your account is approved by a UCLA administrator (usually within one business day), you'll receive an email with a link to set your password and register for the 2022 Interview Program. ## All Employers - Register for the 2022 Interview Program

- Login to your <u>UCLA LL.M. Interview Program Symplicity</u> account.
- o From the column on the left click "OCI." A dropdown menu will appear.
- Click "Schedule Request."
- Scroll down and click the blue box that says "Request a Schedule."
- o Fill out the "Schedule Request" form, which seeks information about your hiring criteria and other data. If you're uncertain about some information, leave those sections blank, and you can return to complete them closer to the event date.
- Click "Submit."
